| | On the Plusha front, I had a good meeting with Lee Quinney and the project manager, who | |
| | will be taking responsibility for the re-evaluation of options to get a grade-separated | |
| | junction constructed at Plusha. It was encouraging to hear that Cornwall Council and | |
| | National Highways are working together to complete the work and, in due course, develop | |
| | the business case to push for funding from the Department of Transport. | |
| | Following this a more recent meeting has been held with National Highways and CC | |
| | Highways officials following their consultation regarding proposed changes at Plusha and | |
| | other sections of the A30. They have confirmed the crossing at Two Bridges will be left | |
| | open and slip roads will be added to enter and exit Plusha off the A30. They are also close | |
| | to agreeing to the budget which is required for safety mitigation measures to lessen the | |
| | impact we are seeing on our local roads due to increased traffic due to the closure of the | |

right hand turning out of Plusha heading towards Launceston.

Locally, concerns have been raised regarding the visibility on the A388 and at various junctions, so I have asked for the Highways steward to look and get the verges cut back where appropriate.

Since April, there have been several complaints regarding changes to the number 12 and 76 bus services, which has been split into three sections, being a mix of commercial and subsidised services. Peak end-to-end. With that in mind, these changes were considered low impact but widely publicised since registrations were submitted in early March. The shame is the Bude to Plymouth service was one of our best-used locally. Now, by splitting the journey, it's added time, inconvenience, and extra cost for users. It's not working well and has proven unpopular. Working with Cllr Adam Paynter and Cllr Andrew Long, we are looking to get this decision overturned and have a meeting to discuss this matter tonight. Just to update, we had a meeting last Monday with Go Cornwall the transport provider, Cornwall Council transport and local fellow councillors. The consensus is that clearly the changes haven't worked! The challenge is that since the Government have cut the rural subsidy grant for transport, we're told this service is losing over £250k a year, which is a worry, as it was one of the best used runs in the area. If it were to remain as it is patronage would only be lost further. It's now looking like the service will go back to as it was before, but this hasn't been fully clarified yet. It's expected that the route from Launceston to Callington will be treated as one journey with a charge of £3 and then from Callington to Saltash there will be an additional charge of £3. Then a further charge once in Devon. They say this is to make it more viable!

Clearly this will make the trip more expensive; by purchasing an adult day pass it will cap journeys to £8.

We are doing what we can to return back to a reliable service which residents can have confidence in using.

Regarding committee places I will be sitting on East Planning to which I've been voted in as the Chairman, along with Strategic planning and Licensing.

Also, FYI there will be some disruption on certain sections of the A30 this week. The Chairman invited Ian Scott (IS) to give a report of the 9th June meeting with National Highways (NH) regarding Plusha Junction:

This was the first meeting since the meeting held in Lewannick last year. Jack Mason (JM), NH, launched straight in to the proposed mitigation measures. The crossing at Two Bridges is not going to be closed as per the original proposals. There will be an additional pavement either side of Hawks Tor Drive, road narrowing signs near the Church and proposed changes to priorities at the junction by the Church, The Archers and the Village Hall. There will be slip ways on and off at Plusha and the problems at Landers Lake will be addressed. No plans to widen Trekelland Bridge but will provide width markers to indicate the width of the bridge (this will not work due to the curve in the centre of the bridge which will not give enough width for large vehicles crossing). Rick Clayton (RC), Cornwall Council Office for working through the NH plans for a Grade Separated Junction (GSJ), then spoke about the issues with deliverability of the proposed schemes put forward in 2015, but gave no specific details. If a GSJ is delivered then the other crossings, Kennards House and Five Lanes will be closed. Whilst it was acknowledged that there will be unwanted disruption for 18 months or so, it would not want this to be the reason for not delivering a GSJ. RC talked about a Feasibility Study for a GSJ at Two Bridges instead of at Plusha and the underpass at Trevell. This needs to be questioned because it would push more traffic through Lewannick and it would not make sense for traffic wanting to access the B3254 via Old Hill, Lewannick instead of directly from Plusha. Cornwall Council is going

| | to be utilising the surveys and modelling from NH, but again there was no information on when these surveys took place, (although surveys are being scheduled by NH for this week on the A30). There was some discussion and it was felt that logistically it makes more sense for the GSJ to be at Plusha. It was felt that it would be useful to have a meeting with RC and a small group of representatives from the affected Parish Councils.
